Law of the Republic of Tajikistan

ABOUT PATRIOTIC EDUCATION OF CITIZENS

Adopted by the Resolution of MN MORT

dated November 2, 2022, No. 887

To be approved by the MM MORT

Resolution of December 16, 2022, No. 332

This Law establishes the goals, principles and directions of patriotic education in the Republic of Tajikistan, its legal and organizational foundations, defines relations related to the creation of legal, social, economic, organizational foundations, provision and regulation of activities in the field of patriotic education of citizens.

**CHAPTER 1. GENERAL PROVISIONS** 

Article 1. Basic concepts

The following basic concepts are applied in this Law:

- The fatherland is Tajikistan, a country native to a person, social or national community of people, belonging to which they perceive as a necessary condition for their well-being;
- patriotism love for the Motherland, your people, the desire to serve their interests by your actions, protect them from enemies;
- state support of subjects of patriotic education -

the totality of the complex adopted and implemented by state bodies

organizational measures of educational, informational, financial, economic, legal and other nature aimed at creating

favorable conditions for patriotic work;

- authorized state body in the field of patriotic
   education of citizens the central executive body of state
   power of the Republic of Tajikistan, implementing state policy in the field of patriotic education of citizens;
- the system of patriotic education of citizens a set of subjects
   of patriotic education, legal and spiritual and moral framework
   educational, educational and mass educational activities, as
   well as a set of measures for the formation of patriotic feelings and consciousness
   of citizens;

- education is a social, cultural, psychological and pedagogical
   phenomenon, as a specially purposeful human activity
   that contributes to the development of the potential of the individual and its realization in the process
   of life and the construction of the cultural life of society, serves
   to streamline the lifestyle of a person and the development of society.
- patriotic education systematic and purposeful activities of state authorities, self-government bodies of settlements and villages, public organizations (associations), families and citizens to form a high patriotic consciousness among citizens, a sense of loyalty to their Fatherland, readiness to fulfill civic duty and constitutional obligations to protect the interests of the Motherland;
- spiritual and moral education a set of measures aimed at the awareness of the personality of higher values, ideals and guidelines, socially significant processes and phenomena in real life, the ability to be guided they are used as defining principles, positions in practical activities and behavior aimed at worthy service to the Fatherland;
- civil-patriotic education a set of measures
  aimed at educating citizens of the conscious need
  for selfless, selfless service to the Fatherland in the performance
  of official, labor and public duties, love for their native land,
  the formation of legal culture and law-abiding, high morality
  and general culture, a clear civic position, constant readiness for
  fulfillment of their constitutional duty and civic duties,
  pride in belonging to the outstanding deeds of their ancestors and their traditions;
- military-patriotic education a set of measures aimed at forming among citizens a conscious need to protect the Fatherland, preparation for military service, education of pride in belonging to their people, to their achievements, for the Armed Forces of their country, respect for national history, military service and uniform, formation of orientation to the preservation, multiplication of glorious military traditions of the ancestors, perpetuation of the memory of soldiers who died defending the Motherland;
- citizenship the orientation of the individual in the interests of the state and

society, as well as the system of relations,

behavior and activity of the individual in the conditions of the state corresponding to this orientation.

Article 2. Legislation of the Republic of Tajikistan on

patriotic education of citizens

The legislation of the Republic of Tajikistan on patriotic education of citizens is based on the Constitution of the Republic of Tajikistan and consists of this Law and other regulatory legal acts of the Republic of Tajikistan and international legal acts recognized by Tajikistan.

CHAPTER 2. STATE POLICY IN THE SPHERE OF

## PATRIOTIC EDUCATION OF CITIZENS

Article 3. Goals and objectives of patriotic education of citizens

- 1. The goals of patriotic education of citizens are:
- formation of citizens' civic identity of high moral qualities, national mentality, consciousness and patriotic feelings;
- instilling in citizens a patriotic attitude towards society and the state on the basis of high social activity, civic responsibility, readiness and ability to serve the Fatherland and strengthen the state, ensure its vital interests and sustainable development;
- strengthening the foundations of citizenship and patriotism in society as the most important spiritual, moral and social values, the formation and development of the younger generation of the most important socially significant civic qualities and the ability to manifest them in the creative process in the interests of society and the state, including in those activities that are related to ensuring their safety.
- 2. The tasks of patriotic education of citizens are:
- formation of national self-awareness, value attitude to the individual, society, the state, to the ideas and values of their revival and development;
- introducing the younger generation to the system of socio
- -cultural values reflecting the richness and originality of the history and culture of the Fatherland, the people, the formation of high spiritual, moral and cultural values and orientations, the need for their further development;
- creation of favorable conditions for citizens to show feelings,

patriotism, decent performance of public, state and military duty, taking into account their interests and needs in various spheres of human activity and communication;

- education of respect for the law, norms of public life, feelings
   social responsibility as the most important qualities of a person, manifested in caring for the well-being of his country, its strengthening and protection;
- instilling a positive attitude to work as the most important value of life, the need to work for the benefit of society and the state;
- formation of the need for spiritual and moral development, in maintaining a healthy lifestyle, the ability to take care of the elderly and loved ones people, to maintain a favorable climate in the workforce.

Article 4. Principles and main directions of state policy in the field of patriotic education of citizens

- 1. The state policy in the field of patriotic education of citizens is based on the principles of:
- a systematic organizational approach, which involves the coordinated work of all state and public organizations for the patriotic education of citizens;
- targeted and individual work with citizens, a variety of means and methods that take into account the interests and inclinations of citizens, their level of education, social status, etc.;
- universality and interdependence of the main directions
   of patriotic education, assuming a holistic and integrated approach to
   their implementation;
- taking into account national, ethno-cultural and other conditions in the formation of patriotic ideas and values that determine the content and features of patriotism;
- openness and independence of evaluation of the results of the implementation of measures aimed at patriotic education of citizens.
- 2. The principles provided for in part 1 of this Article are interrelated and implemented in unity.
- 3. The main directions of the state policy in the field

of patriotic education of citizens are:

- creation of favorable conditions for the social, cultural, spiritual and physical development of citizens;
- development and implementation of effective forms and technologies of socialization
  of the personality of citizens, especially young people, their active involvement in solving
  socio-economic, cultural, scientific, environmental and other problems
  of the state;
- updating and enriching the content of patriotic education, its methods, forms and means;
- creation of a mechanism that initiates and optimizes the effective functioning of the system of patriotic education of various categories of citizens at all levels;
- strengthening the responsibility of state bodies for the patriotic education of citizens;
- expansion of subjects of patriotic education;
- creation and improvement of the legal framework for patriotic education of citizens.

Article 5. Subjects of patriotic education

- 1. The subjects of patriotic education are:
- state and other bodies that carry out management in the field of patriotic education of citizens;
- labor, creative, scientific, military and other collectives;
- educational institutions;
- cultural institutions;
- public, public-state organizations (associations)
   of citizens and compatriots living abroad;

,

- religious organizations (associations);
- political parties;
- mass media;
- family;
- citizens.
- 2. Subjects of patriotic education with specific capabilities and

means solve problems in the field of patriotic education of citizens of the country.

Article 6. Competence of the Government of the Republic of Tajikistan in
